

### **COMMUNITY PROFILE**

The Town of Menasha lies in the "Fox Cities" area of Wisconsin, near the northwest corner of Lake Winnebago, about thirty minutes southwest of Green Bay. The Town of Menasha has enjoyed steady growth for many years, and is presently the second largest township in Wisconsin with a population of over 18,000.

The Town of Menasha has a service area of 12.3 square miles that includes two major federal highways that intersect within those boundaries. Approximately 66,000 vehicles cross USH 10 each day, and another 91,000 vehicles travel on USH 41 each day. In addition, the Town of Menasha maintains approximately 100 miles of local roadways.

The agency has a variety of zoning types within its jurisdiction, ranging from industrial/commercial to agricultural/residential. The economy of the area is based upon the paper industry and the town is home to many large corporations including Pierce Manufacturing, Kimberly Clark, SCA Tissue, CelluTissue, Outlook Corp., Great Northern and many other great businesses.

The police department is a full service police department employing 26 sworn officers and 7 civilian employees, with a \$2.8 million dollar budget.



### PATROL DIVISION

The patrol division is the backbone of the police department. This division is responsible for handling a majority of the many emergency and non-emergency calls received each year, along with enforcing traffic laws on the freeways and roadways throughout the Town of Menasha.

The Town of Menasha presently has 15 officers and 4 lieutenants that are assigned to this division. These officers are then split among 4 patrol shifts, each with a lieutenant, that provide coverage 24 hours a day, 7 days a week. At any given time there are between 3 and 5 officers working each shift, depending on the time of day.


Officers primarily conduct their patrols from police cars. The Town of Menasha utilizes six marked patrol vehicles. This has traditionally been the primary means of providing police services, but we have also initiated alternative patrol methods.

Our officers also get out of their patrol cars and will either patrol certain areas of the town on bicycle or foot. These efforts afford the officers the opportunity to interact more freely with the

residents outside of the "confines" of a patrol car. Officers are also periodically assigned to a specialized directed patrol. This places officers in certain areas of the town due to a high call volume.

This past year proved to be quite a busy year for our patrol officers. *During the course of 2011, our patrol officers responded to 6,792 calls for service!* Often we are asked which of our patrol shifts is the busiest. The following chart shows a breakdown of calls between the shifts.



In addition to responding to calls for service, our patrol officers enforce traffic laws on over 100 miles of town roads in addition to USH 10/441 and USH 41. *Officers issued 2,313 citations along with taking 87 intoxicated drivers off of our roadways.* 



### PATROL DIVISION

Some of our calls for service tend to be repeat calls at the same address. A majority of these calls can be classified as a nuisance to the neighborhood. These calls tend to lead to a lot of frustration not only for the residents but for the officers repeatedly responding. To address that concern, the Town of Menasha started a chronic nuisance program in 2008. This program allows us to notify and assist property owners in curbing nuisance activity on their property. The chart below highlights the number of targeted properties since 2008.

On Easter Sunday morning, a day shift officer overheard a robbery that had just occurred at a Grand Chute movie theater. A short time later, the officer noticed a man matching the description near W. Prospect Ave. and Bluemound Dr. The suspect – armed with a handgun and bag of money – took off running. After a brief foot chase, the man was taken into custody at gunpoint.

During the month of June, we experienced 40 thefts, with almost all of them coming from unlocked vehicles on the west side of the Town of Menasha. In response to this rash of thefts, our patrol officers placed a "bait car" in strategic areas of the town. This vehicle was wired with an alarm connected to our dispatch

center. Night shift officers had the vehicle out on seven different nights and unfortunately we were not able to attract any attention to the car. We plan to continue using the bait car in 2012.



In addition to patrolling the streets of the Town of Menasha, our patrol officers were able to participate in a few fun activities last year. In March, we faced a group of TMFD firefighters in our second annual charity basketball game. This time we were able to raise over \$1,500 for Children's Hospital of Wisconsin.



### **INVESTIGATION DIVISION**

Criminal investigations are an important aspect of the services that we provide. Each Town of Menasha police officer has received training to conduct thorough and complete investigations. Officers routinely conduct investigations and frequently resolve the issue with no additional assistance. Those investigations that require additional or technical assistance are forwarded to the Investigation Division.



The Town of Menasha Police Department Investigation Division consists of 1 lieutenant, 2 detectives and 1 MEG drug unit investigator. The Investigation Division is responsible for investigative follow-up and criminal case preparation related to the prosecution of persons suspected of committing crimes and arresting persons suspected of committing crimes.

The department also has several officers that are trained as evidence technicians to provide forensic assistance in these investigations.

These evidence technicians will respond to major crime scenes to collect and process any physical evidence. This allows the detectives to

focus on interviewing victims, witnesses and suspects. The evidence collected is then submitted to the Wisconsin State Crime Laboratory in Madison for analysis.

In early 2011, the police department replaced its aging evidence response vehicle. This vehicle was a 1995 Chevrolet Astro van that originally saw service as the department's K9 vehicle. Our new vehicle is a 2011 full size Ford van that with research, planning and town staff to equip the vehicle, cost less than a new squad car!



The Investigation Division works closely with the Winnebago County District Attorney's Office as well as many other agencies both locally and nationally. Our investigators meet regularly with other Fox Valley agencies to share and obtain information regarding criminal activity in and around the Town of Menasha. The information shared at these meetings has proven invaluable and has directly resulted in crimes being solved not only here in the Town of Menasha but throughout the Fox Valley.

### **INVESTIGATION DIVISION**

Major drug investigations in the Town of Menasha are conducted by the Lake Winnebago Area Metropolitan Enforcement Group (MEG). The MEG Unit consists of 13 officers from police and sheriff's departments in Winnebago, Outagamie, Calumet and Fond du Lac counties. The Town of Menasha has had several officers assigned to this unit since it was formed in 1988. In 2011, the MEG Unit conducted over 30 investigations in the Town of Menasha focusing on marijuana, prescription drugs, cocaine, and heroin.



In the statistics area of this report you will find a table that lists 8 crimes broken down into two categories: violent and property. These are the crimes submitted to the FBI's Uniformed Crime Reporting system. In 2011, we saw 57 violent crimes committed in our community, with 54 of those being assaults and batteries. We are proud to report that 100% of our violent crimes reported were solved!

One of those violent crimes occurred on August 13 when two groups of people were involved in an altercation at a local nightclub that resulted in several gunshots being fired from a vehicle towards the crowded nightclub. Several vehicles were struck with bullets along with a man who suffered a gunshot wound to the face. The investigation yielded several arrests and there is presently an arrest warrant issued for the shooter.

In the property crimes portion of the report, we saw an increase in burglaries and thefts declined slightly from 2010. In 2011 the police department joined a service known as LeadsOnline-an investigative system that enables detectives to search for suspects and stolen property across secondhand stores, scrap metal dealers, pawnshops, and internet (eBay) drop-off stores both locally and nationwide. This new tool was directly responsible for recovering over \$6,000 in property in 2011!



### **COMMUNITY POLICING**

Although a major function of the police department is responding to calls for service and investigating crimes that are committed, the Town of Menasha Police Department firmly believes in being actively involved in the community.

Community policing is a concept that saw its origins in England back in the early 1800's. Sir Robert Peel, known as the "Father of Modern Policing," is credited with establishing the modern concept of the police force. He realized that a partnership must exist for the success of the community and the police. Participation by all facets of the community is critical for real problem solving that leads to lasting solutions. A famous quote from Peel is "the police are the public and the public are the police".



Informing the public of what is occurring throughout the community and the region is critical to community policing and crime prevention. Historically, we have shared information through meetings and presentations with various groups such as Neighborhood Watch, businesses, and civic organizations.

Last year our Community Liaison Officer gave 48 presentations on a variety of topics and we also conducted two sex offender notification meetings and visited the students at Spring Road School with the Officer Friendly program in the spring and fall. In an effort to help residents and businesses protect their property, we conducted 8 security surveys.

In April we held the first citizens' police/fire academy. The academy focuses on the duties of a police officer, firefighter and paramedic and offers attendees the opportunity to experience those duties through a variety of hands on activities.



We also held our 8<sup>th</sup> annual National Night Out on August 1. This event continues to be a success each year and was attended by close to 1,000 people in 2011! Department members also participated in the Affinity Clinic Helmet Challenge day and the fire department's Safety Day.

In partnership with the Neenah and Menasha Police Departments, we held two Cheers: Responsible Beverage Server Training classes and a Landlord Training class.

### **COMMUNITY POLICING**

In 2011, the police department continued expanding our presence on the World Wide Web and launched a newly revamped website. The website now provides links to many handouts and resources. We also partnered with RAIDSONLINE to offer a free crime mapping service whereby residents can see exactly what is occurring in their neighborhoods.

We also continue our communications with the community through our Facebook site, Twitter account, Nixle text message alerts and YouTube channel.











In addition to the many social media methods of communication we still rely on the traditional media. Our Community Liaison Officer also serves as the spokesman for the department and in 2011 we issued 24 press releases and the department was featured several times in the news media on crime prevention topics.



The police department works collaboratively with other agencies in programs such as:

- > TRICOM a Winnebago Countywide coalition of citizens who represent businesses, civic organizations, and schools who work in cooperation with the law enforcement agencies of Winnebago County.
- P.A.S.T. Police And Seniors working Together) – The police department actively participates in the Northern Winnebago County P.A.S.T. groups' monthly meetings and community presentations.
- Winnebago Countywide Crime **Stoppers** - This is a coalition made up of citizens and businesses whose vision is to encourage community involvement in solving crimes. Crime Stoppers encourages people to assist police in solving crimes by offering rewards.
- re:TH!NK This is a coalition of over 100 public, private and non-profit organizations throughout Winnebago County aimed at reducing substance abuse.
- WI Crime Prevention Practitioner's **Association - Our Community Liaison** Officer serves on the board of directors of this state organization. This allows the Town of Menasha to have a voice on the state level and help to initiate new and innovative crime prevention methods and bring those back to our community.

### **SUPPORT SERVICES**

#### **COMMUNICATIONS AND RECORDS**

The Town of Menasha Police Department's Communication and Records Division serves the citizens in a variety of ways. This division is open to the public 24 hours a day, 365 days a year. This division is generally the first point of contact the public has with the police department. Communication Technicians are those employees who receive the public's phone calls and greet those that come into the lobby.



In addition to serving the citizens of the Town of Menasha, the Communications and Records Division provides support to our sworn personnel. The division monitors cameras placed in and around the municipal complex, and routinely provides searches of Federal, State, and local databases to assist officers with locating information that is pertinent to their cases and investigations.

The Communications and Records Division is responsible for maintaining the information that is entered into these systems. Information is entered into local, State, and Federal databases, and must be done so in accordance with various laws and system regulations. These entries include missing persons, stolen and recovered articles and vehicles, and arrest warrants. In order to ensure a high standard of accuracy, routine audits are conducted on these systems.

The Communications and Records Division is also responsible for typing all of the officers' dictated reports. Any incident that involves an officer's response and investigation typically will require that officer to dictate a report. These reports are then filed electronically and any attachments are filed in cabinets.

#### **EMERGENCY DISPATCH**

The Winnebago County Sheriff's Department is responsible for answering 911 emergency calls and dispatching emergency services throughout Winnebago County. The 911 Communications Center is located on the second floor of the Sheriff's Office. The 911 Communications Center is staffed 24 hours a day, 365 days a year. There are three shifts per day with five or six dispatchers on duty each shift.



### **SUPPORT SERVICES**

#### **TRAINING**

The State of Wisconsin requires that sworn officers attend 24 hours of training annually to maintain their law enforcement certification.

Our officers attended 1,610 hours of training in 2011. This averages to nearly 62 hours of training for each officer.



This training included firearms qualifications-which occur twice a year, along with annual legal updates on new laws and court rulings. Officers also attended a variety of specialized training such as: Drug Recognition Expert, Sovereign Citizens, Evidence Technician, FBI – Interview & Interrogations, Officer Involved Shootings, and many other topics.

In April, the department hosted a training session on Scrap Metal Theft Investigation and Prevention. This training featured several speakers and was attended by officers and investigators from throughout Wisconsin.

#### **SWAT**

The Town of Menasha Police Department has partnered with the City of Appleton Police Department for over 20 years to provide assistance for any tactical situations in our community. We have two officers that are assigned to the Appleton SWAT team along with one officer assigned as a negotiator.

#### **HONOR GUARD**

In 2010, the department formed an honor guard to represent not only the police department, but the community at formal events both here in the Town of Menasha and around the state. The unit is comprised of one lieutenant and five patrol officers.

In 2011 the honor guard attended several events such as the annual town meeting, a 9/11 memorial event and funerals for fallen officers in the area.

- Complaints indicate the number of police reports and investigations done by officers.
- **Services & Assists** indicate the number of times officers have assisted citizens, motorists, other agencies, etc. Many times these incidents do not generate a police report.
- **Traffic Stops** indicates the number of times officers stop a vehicle for a traffic violation. These may result in a citation(s) or warning(s) being issued.
- Accidents are those reported to the police department occurring either on roadways, parking lots and/or private property.

The Federal Bureau of Investigation's Uniform Crime Reporting (UCR) Program, which began in 1929, collects information on the following crimes reported to law enforcement: homicide, forcible rape, robbery, aggravated assault, burglary, theft, motor vehicle theft, and arson.

The UCR Program also maintains a database of arrests and clearance rates of law enforcement agencies.

Clearance rates reflect the percentage of those cases that are cleared or solved.

The statewide clearance rates for 2010 were: 50% for violent crimes and 26% for property crimes.

# **CRIME CLOCK**
