



LITTLE ME LEARNING PRESCHOOL PROGRAM **FREQUENTLY ASKED QUESTIONS**

- **Is Little Me Learning only available to Fox Crossing Residents?**

Our Little Me Learning program is available to everyone, regardless of what your local residency is.

- **My child turns 3 after the program begins, will you make an exception and let them in?**

We consider this program to be a 4K readiness program. To attend 4K in local school districts, the student will need to be 4 years old by September 1 of the upcoming school year. Because of this, we like to stick to the same guideline and require the Little Me Learning students to be 3 years old by September 1 of the school year. In some very rare cases an exception may be made at the discretion of the Little Me Learning instructors.

- **Do I have to pay the entire program fee at the time of registration?**

There are two semesters for the full school year. The entire fall semester payment is due at the time of initial registration. The winter semester payment is due by December 31.

- **Can I just sign up for the winter session?**

This is a full school year program with two semesters (fall and winter). Students must enroll in the fall semester to be eligible for winter semester participation. It is expected that families that enroll in the fall semester also have the intention to register for the winter semester.

- **If I decide to cancel my registration do I lose the full program fee?**

A \$50, non-refundable registration fee is included in the program cost. If you decide to cancel after you have registered, you will receive the program fee minus the \$50 registration fee. No refund requests will be honored after August 1.

- **Will my child need to bring supplies to class?**

A school supply list will be available by July 15. We will have approximately \$20 worth of classroom supplies for students to bring in for the classroom. We also ask that students bring a backpack or bag, just big enough to hold a change of clothing.

- **Do you follow a local school district's calendar?**

We follow the Neenah Joint School District calendar. The majority of our no-school days will reflect the no-school days on the Neenah Joint School District's calendar (Spring Break, etc.). There may be some exceptions made. This same process is in place for inclement weather days, if the Neenah Joint School District cancels school for inclement weather, our classes will also be cancelled. If there is a 2-hour delay due to weather, classes will be cancelled.

- **Will there be an Open House scheduled so we can see the classroom and meet the teachers?**

There is an Open House scheduled for Friday, January 12 from 10:00AM-Noon. If you can't make that time it's possible the teachers can arrange a separate time after regular class hours if need be, to meet with parents and answer additional questions. Please contact the Parks & Recreation Office to check availability.

- **Will there be a Meet the Teachers Day prior to the school year beginning?**

There is always a day scheduled in August for families to stop in, meet the teachers and see the classroom one more time before the school year officially begins. Registered families will be notified of that date in July.
