## MESSAGE FROM THE VILLAGE PRESIDENT

As we look back on 2023, it has been a year of many accomplishments for the Village of Fox Crossing. Numerous capital projects were conducted including the replacement of water and sanitary sewer on Brighton Beach Road, the renovation of Butte des Morts Park playground (with a new kayak launch coming during 2024) and completion of Rocket stormwater pond on West American Drive.

Additionally, the Village made significant progress on the installation of Sand Point pond on East Shady Lane and Church pond on Jacobsen Road. The investment in these stormwater ponds will aid the Village in reducing localized flooding issues, assist the Village in meeting required stormwater particulate reductions set forth by the State and allow the Village to conduct future road projects to improve East Shady Lane and Jacobsen Road.

During 2023 the Village continued to face the same headwinds of economic uncertainty and inflation that have impacted other municipalities, private businesses and individual households. These economic factors have increased the costs of construction, energy and personnel wages. In spite of these ongoing challenges, the Village received notice from Moody's Investor Services that the credit rating for Fox Crossing Utilities was upgraded from A1 to Aa3. The upgrade was due to our strong financial oversight, moderate leverage and fixed costs, and strong liquidity. We are very proud of this accomplishment and plan to continue to provide responsible oversight to all taxpayer and utility customer dollars.

Also during 2023 we had the opportunity to see the opening of the new Neenah High School in Fox Crossing. As we officially welcome the school to the Village we congratulate the Neenah Joint School District, Miron Construction and all those who worked on the construction of the new school. It is truly a privilege for our students to receive their education in such a fine, modern facility.

Finally, 2023 included an event that has become very uncommon in today's world. Long-time Village Street Superintendent Randy Gallow retired from the Village after 48 years of service to the Town of Menasha/Village of Fox Crossing. Superintendent Gallow started as a part-time street laborer in the fall of 1975 and became a full-time employee in June, 1978. For the past 45 years Randy has overseen the construction, maintenance and plowing of Village streets. He will be sorely missed by all. Congratulations to Randy!

As always I extend Happy Holiday Wishes to all residents of Fox Crossing as well as good health and prosperity during 2024.

Discarded Christmas trees will be collected by Harter's Fox Valley Disposal the week of January 8 **ON YOUR GARBAGE DAY**.

- Please do **NOT** place your Christmas tree at the side of the road more than 48 hours prior to your collection day.
- Please have the "cut end" toward the road for easier handling.

## PRACTICE SMART SALTING

What some people don't realize is the products used for snow and ice removal can harm our local waters. When ice and snow melt, the salt, sand and chemicals used flow into our street drains leading directly to our waterways. Stormwater is not treated before it flows into our waterways.

### YOU CAN PRACTICE SMART SALTING BY:

Shoveling early and often to prevent snow compaction and ice buildup.

Using salt sparingly by scattering salt grains approximately 3 inches apart, remember a little goes along way!

Limit the use of sand. Sand provides traction but does not remove ice. Sand should only be used when absolutely necessary.

Salt, sand and chemicals used for ice removal can never be removed from our waters!

Recently, the Wisconsin Elections Commission approved new designs for these envelopes for mandatory use beginning with the 2024 Elections. The new envelopes ensure compliance with Wisconsin law and are much more usable for both voters and election officials.

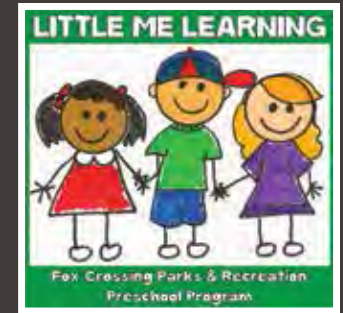
These envelopes are much more colorful, and therefore will stand out better in the mailing system as well both in Wisconsin and nationwide.

# FOLLOW THE "9PM ROUTINE"!

The Fox Crossing Police Department encourages you to practice the "9PM Routine." The 9PM Routine is a nightly reminder for residents to remove valuables from their vehicles, lock their vehicle doors, lock the doors to their residences, turn on exterior lights, and activate all alarms and security systems.

Criminals look for easy targets. You can make it more difficult for them by following the 9PM Routine! Many vehicle burglaries, and to a lesser degree, stolen vehicles, occur as a result of vehicles being left unlocked. Criminals walk through neighborhoods trying vehicle door handles hoping to find an unlocked vehicle. The best way to prevent vehicle burglaries and thefts is to remove all of your valuables, lock your vehicle's doors upon exiting, and take your garage door opener and keys to the vehicle inside your residence.

## ARE YOU READY FOR THE 2024 ELECTIONS?

The process to verify or modify your voter registration has been simplified and can be completed at the Clerk's office or online at [www.myvote.wi.gov](http://www.myvote.wi.gov).

If you're a brand new voter, have recently moved, or experienced a name change, you will need to complete the voter registration process. It's as simple as creating or searching for your voter record by entering your name and date of birth on My Vote. The website will direct you from there as long as your Wisconsin Driver's License/Photo ID is current. If your ID has yet to be updated, please contact the Clerk's office (920) 720-7103 for assistance.

Even if you're a long-time resident, it's always a great idea to confirm your voter registration information is current and accurate.

The My Vote Wisconsin website can also assist in requesting and tracking absentee ballots, locating your polling place, finding contact information for the Clerk's office, previewing a sample ballot prior to Election Day, and so much more.

You can always come visit us at the Clerk's Office to register to vote, update registration information, and request an absentee ballot!

## FRAUD PREVENTION



By the time most frauds or scams are reported to law enforcement, it's often too late to do anything about it. The work we do has to be proactive, not reactive.

## DIAL-A-RIDE PROGRAM

If you are a Village of Fox Crossing resident age 60 or older, and you are ambulatory, you are eligible for "Dial-A-Ride" Transportation.

It's as easy as its name: Dial-A-Ride! Once you have completed the application and have received your tickets from the Village of Fox Crossing, all you have to do is pick up the phone and contact the transportation company.

### Dial-A-Ride Transportation Hours:

**6:00 AM – 7:00 PM: Monday through Friday**

**6:00 AM – 2:00 PM: Saturday**

**By Reservation Only: Sunday**

Transportation is not available on New Year's Day, Memorial Day, July 4th, Labor Day, Thanksgiving Day, or Christmas Day. For more information, go to [www.foxcrossingwi.gov](http://www.foxcrossingwi.gov) or call Tami in the Finance Department at (920) 720-7106.

Please be advised that rates may change from year to year.

## 2024 DOG/CAT LICENSING

All dogs and cats over five months of age are to be vaccinated and licensed. The fees are \$7.00 for neutered/spayed, or \$12.00 for non-neutered/spayed.

Dog/Cat Licenses expire yearly on December 31. In order to avoid the late penalty fee of \$5.00, licenses must be obtained by March 31, 2024.



If you become a Village resident after March 31, 2024, the penalty will not apply. Please refer to [www.foxcrossingwi.gov](http://www.foxcrossingwi.gov) for further information.

### Pet Licensing Fee Payment Options:

#### By Mail & Night Deposit Box:

Remit your payment, along with a copy of your pet's rabies vaccination certificate and proof of sterilization from a licensed veterinarian, if applicable. Include a self-addressed, stamped envelope for return of the license and certification information. The night deposit box is located just to the left of the main entrance doors at the Municipal Building. Otherwise, payments can be mailed to:

#### In Person:

Licenses can be obtained at the Municipal Building, Finance Department, 2000 Municipal Drive (corner of E. Shady Lane and County Hwy CB). When applying for a license, owners must present a rabies vaccination certificate and proof of sterilization (if applicable) from a licensed veterinarian. **No license will be issued without proper certification.**

#### No Longer have your Dog or Cat?

If you had licensed a pet in the past and no longer have that pet, please call the Finance Department at (920) 720-7106 or email [tcoenen@foxcrossingwi.gov](mailto:tcoenen@foxcrossingwi.gov) and we will remove the dog/cat from our system.

## WISCONSIN DEPARTMENT OF TRANSPORTATION (WISDOT) I-41 MAINTENANCE IMPROVEMENT PROJECT

In 2024, WisDot will be conducting maintenance on I-41 from Breezewood Lane to WIS 96, which will cause significant traffic impacts within the Village of Fox Crossing. Construction is expected to extend from April 2024 through Fall 2024. Among the most significant are:

Closure of I-41 southbound exit ramp to County II for 14 days in May 2024 and 7 days in September 2024.

Closure of the I-41 Northbound entrance ramp from County II between May 2024 and October 2024.

Closure of North Green Bay Road from the Speedway Gas Station entrance to American Drive between May 2024 and September 2024.

US-10 westbound to I-41 northbound system interchange ramp will be closed for roughly 3 weeks.

Jacobsen Road will be closed at I-41 for up to 1 week for minor rehabilitation of the bridge over I-41.

One lane of Cold Spring Road will be closed under US-10 during daytime hours for roughly 1 month with flaggers directing traffic through the area.

## SCOOP THE POOP

As a pet owner, please remember to be respectful and pick up all pet waste! If your dog poops, you must scoop!

Failure to remove or dispose of excreta left or deposited by a dog is subject to a \$149.20 fine.

A Fox Crossing ordinance requires all pets to be leashed when walking in public places, including Village roadways and designated trails.

A dog or cat is not considered running at-large when the pet is within the limits of the owner's yard or premises.

Pets are not allowed in Fox Crossing parks; however they are allowed on designated pedestrian trails that run through and around the park.

A leash is required to be no greater than 6 feet in length if walking on a trail.

# KEEP OUR WATERS CLEAN

Stormwater is rain or snowmelt and water from things people do that makes its way into the street drains. Stormwater is not the same as wastewater which flows to our wastewater treatment facilities before slowly being released after treatment over time into our waters. Stormwater flows directly from our property into the street drains and eventually into our streams and lakes. Untreated runoff is the biggest threat to our nation's water quality, according to the U.S. Environmental Protection Agency.

## YOUR CHOICES MATTER

Activities like overwatering the lawn, washing vehicles in your driveway or letting fertilizer, leaves or grass clippings get into the street drains contribute greatly to the algae blooms we see and smell in our local waters. Pet waste carries bacteria making people and our waterways sick, so remember to scoop up the poop. Use salt sparingly in the winter for snow and ice removal. Salt can never be removed from our waters.

If you must wash your vehicles or lawn equipment, wash them on your lawn and not on pavement, so the soap and other pollutants sink in to be filtered through the ground. Sweep up your grass clippings back onto your lawn after mowing, don't leave them on the pavement. Let's make the small, important changes that will reduce the contaminants that threaten our water and improve water quality and our lives.

Realize what touches the ground enters the water.



# DIFFERENCE BETWEEN CHIPPING AND YARD WASTE

Brush and Tree Chipping and Yard Waste are different as indicated on the calendar. Here's how to tell the difference between the two:

## CHIPPING

*Performed by Fox Crossing Street Department.*  
Brush & Branches shall be a minimum of 3 feet in length and shall not exceed 6 inches in diameter. The longer the branch is, the easier and safer it is for our crews to handle.

All branches & brush will be neatly and loosely placed along the shoulder of the road with the 'cut' end of the branches facing the roadway.

## YARD WASTE

*Performed by Harter's Fox Valley Disposal.*  
Yard Waste includes leaves, bundled twigs and sticks, roots or shrubs with intact root balls, clean woody vegetative material, and garden debris (no mulch or grass).

Yard waste must be placed out in biodegradable yard waste paper bags or containers with lifting handles (30 gallon capacity or smaller).

# GENERATORS

Generators are basically motors that operate in reverse. They produce electricity when rotated instead of rotating when supplied with electricity. NEC 445 (Generators) and NEC 430.14 (Location of Motors) need to be met for installation. Be aware of any manufacturer requirements for install that could be different than code requirements. No two generators are the same, knowing why you want one and the size needed for you is important in the decision process. An Electrical Permit would be required and inspection performed so that the electrical company can reconnect power.

# DRUG DROP BOX

Too often, unused prescription drugs find their way into the wrong hands. Unused or expired prescription medications are a public safety issue, leading to potential accidental poisoning, misuse, and overdose. This is dangerous and often tragic. Proper disposal of unused drugs saves lives and protects the environment. It's great to see thousands of folks from across the country clean out their medicine cabinets and turn in - safely and anonymously - a record amount of prescription drugs during annual Prescription Drug Take Back Day.



The designated nationally recognized Prescription Take Back Days are: April 27th & October 26th, 2024.

Citizens can drop off unwanted prescriptions at the Village Municipal Complex year-round during business hours. Please follow these simple rules if you plan to drop off your unused prescriptions:

1. PRESCRIPTION pills/tablets/creams/liquids ONLY! Vitamins, supplements, and health care supplies are not accepted in this program!
2. Place your pills/tablets into sealable plastic bags. If you don't have any, they are provided at the Drug Drop Box.
3. Recycle your pill bottles, removing the labels which may contain sensitive, personal information.
4. NO SHARPS! The drug drop box is not a sharps container. Medications in pre-loaded syringes are not accepted, but can be taken to other facilities such as hospital ER's or pharmacies.

Keep branches long for the safety of our crew.

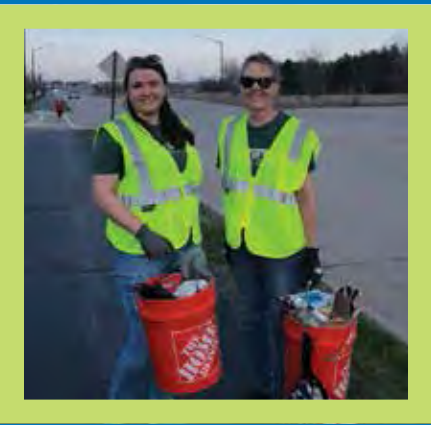

## TRAIL ETIQUETTE

The Village of Fox Crossing supports and maintains over 20 miles of recreational and bicycle/pedestrian trails. Here are friendly trail etiquette reminders so everyone can have a positive trail experience.

### ALL TRAILS

All trail guests – stay to the right, the traffic is two-way.

Just like on the road, faster trail users should pass slower users on the left. Before you reach them, be sure to give an audible warning with a bell, or call out "on your left!" This will give them time to clear the way.

At busy areas, walk no more than two abreast.

Pets on the trail are permitted to be on a leash. Please remove/clean up all pet waste.

Stop, look and listen for motor traffic before crossing the road.

Don't litter along the trails.

### TRESTLE TRAIL

**FISHERMEN** – fish from the fishing platform and other bump-outs only. No fishing is permitted from the trail.

**ALL TRAIL GUESTS** – no stopping or standing on the bridge, and please use the bump-out areas.

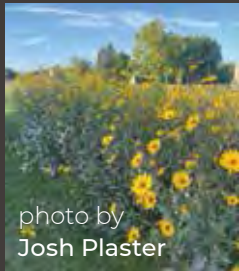

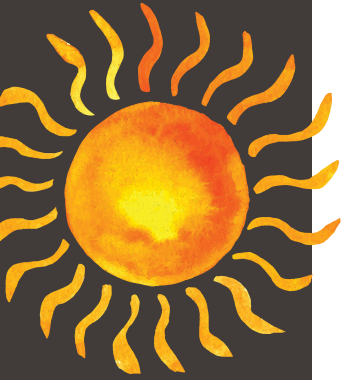

## DO I NEED A PERMIT?

The Village requires permits for a number of projects. Below are our most common items found to be done without a permit. Consider calling to understand what is required, so you don't receive a letter of non-compliance or a stop work order on your project.



- ✓ Roofing
- ✓ Siding
- ✓ Fence\*
- ✓ Shed \*
- ✓ Temporary Pools

## FISH DON'T SWIM IN CHLORINE

Taking the time to follow the proper procedures when discharging water from your pool or spa will help keep our waters a healthy place for fish and other aquatic life.

- Dechlorinate the water.
- Discharge water onto grass or landscaping.
- Monitor the discharge.
- Protect local waterways.

If a pool or spa has been acid washed, the water may not be discharged off the property. Water from back flushing pool filters should only be discharged to the sanitary sewer (down a sink or toilet) or on-site septic tank system where it can be treated prior to entering local waters.

Remember it is illegal in all communities to discharge pollutants, including chlorinated pool water, into a storm drain.

# SEPTEMBER 2024

## LEAF BURNING PROHIBITED

The burning of leaves is prohibited in the Village of Fox Crossing. Penalties for violating the amended ordinance may consist of a fine from \$50-\$200, plus the costs of emergency personnel and vehicles that may have to respond to the fire.

# LOOSE LEAF FALL PROGRAM POLICY

The "Loose Leaf Fall Collection Program" will start the week of October 21 and end on December 6. Leaves are collected in the fall using village equipment and village staff. Residents are asked to put their leaves out by 6AM and no more than 48 hours prior to their scheduled pickup and throughout the program.

For all curb and gutter areas of the village, residents must place loose leaves (no bags) onto the terrace area, along the curb line, and within 8' of the back of curb for leaves to be collected. There is no height restriction on the height of the leaf piles.

In areas with ditches (no curb & gutter), residents must place loose leaves (no bags) along the front slope area of the roadway between the edge of shoulder (not on the shoulder) and the center of the ditch line. Please do not place leaves in the ditch line which could block drainage. We ask residents to avoid filling up ditch areas with leaves. Doing so will help avoid flooding issues. More importantly, it will avoid problems with the collection of the leaves. When the leaves are wet there is the possibility equipment will plug up, which creates more work and down time for the staff.

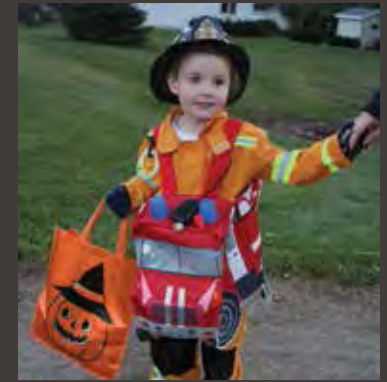
Once the program starts, continue to place leaves out for pick-up. This will help crews stay on schedule when the leaves begin to get heavy and work slows down due to the volume of leaves. Remember you may also put your leaves in bags for Harter's to pick up on the designated weeks on the calendar that say Yard Waste. Burning of leaves is no longer permitted in the Village of Fox Crossing!

# WHAT DO I DO WITH?

## GARBAGE AND RECYCLING

**AMERICAN FLAGS:** Village of Fox Crossing (2000 Municipal Dr. Neenah), Neenah City Hall (211 Walnut St. Neenah), VFW Menasha (546 3rd S. Menasha).

**LATEX PAINT:** Outagamie County Landfill (1919 Holland Rd. Appleton) accepts "100% acrylic", "Water-based" and "Washable". Otherwise Latex is considered non-hazardous and is safe to dispose in the garbage as long as it is DRIED out.

**HOLIDAY LIGHTS:** Are not allowed in recycling carts. Often there is a collection box inside the Municipal Complex or the Winnebago County Solid Waste will accept them.

**USED ENGINE OIL:** Any clean used engine oil can be brought to our drop-off site at the Fox Crossing Municipal Complex. This site is monitored by security camera and is open 24/7. Please take your empty containers with you.

## WINTER PARKING ORDINANCE

The Village does not permit overnight parking on all public roadways between November 1 - April 1 from 2AM-5AM in order to allow effective, unobstructed plow operation and snow removal during this period of little to no vehicular traffic. A snow emergency can be issued when snow is falling in such a manner as to produce a congestion of traffic or impede the operation of emergency vehicles. In the event of a declared snow emergency, parking on Village roadways is prohibited until the emergency is deemed over.



## POLICE LIGHTS OF CHRISTMAS PROGRAM

The Lights of Christmas Program was created by Q90 FM as a means for law enforcement to create positive interactions with the community. It has grown to include approximately 70 Wisconsin police agencies, including the Fox Crossing Police Department. ## LOTTERY & GAMING CREDIT

**Check your tax bill!** If you do not have a Lottery & Gaming credit on your tax bill, you may still be eligible. You can complete the form when making your payment in person at the Village Municipal Complex or refer to the Village webpage above to print the form. The completed form can be returned via mail with your payment to the Village Treasurer prior to January 31.

**To Qualify:** You must own a home in Wisconsin AND your home must have been occupied as a PRIMARY residence on January 1. A primary residence is defined as the home in which a property owner lives for more than six months of the year. If temporarily away, a primary residence is the home to which the owner returns.



- \* Chipping/Leaf Vac collection is done by The Village of Fox Crossing Street Department and won't ever change a pickup date due to a holiday.
- \* Garbage/Recycling/Yard Waste/Christmas tree collection is done by Harter's and could change a pickup day due to a holiday.
- \* Place your carts out the night before collection day to avoid being missed!
- \* Garbage is picked up weekly. Recycling is picked up bi-weekly.
- \* Visit our website or call the street department to determine if your recyclables are collected on "A" or "B" weeks.
- \* PLEASE NOTE: Last leaf collection for 2024 will be the week of December 2 on your garbage day.

# HELPFUL INFORMATION

## ◆ CART PLACEMENT

- \* Must be 3-5 feet away from each other and from any obstacle (ie: mailbox, parked car on roadway, etc).
- \* Must be placed curbside by 6:00 am (**placed curbside the night before collection is recommended**).
- \* The front of the cart (where the serial number is printed) must face the road.
- \* Lids must close completely on the carts.
- \* **Winter placement:** On your driveway after you have cleared it of snow. **DO NOT** place on top of snow banks!
- \* If your cart is tagged for a violation, it will not be collected until your next regularly scheduled collection day.
- \* Carts must be returned to their point of storage prior to 8:00am on the day following your collection day.

## ◆ CURBSIDE RECYCLING

- \* Place all recyclable materials loose in the recycling cart.
- \* **DO NOT** use, or dispose of, plastic bags of any kind in your recycling cart.
- \* Plastic motor oil bottles are **NOT** recyclable! Put plastic motor oil bottles in the trash.
- \* **Excess paper recyclables and cardboard boxes can be dropped off (at no charge) in the crates at:**  
Paper Valley Recycling - 1420 Earl St, Menasha, Mon - Fri between 7:00a - 3:00p.

## ◆ HOUSEHOLD HAZARDOUS WASTE

Items can be taken to the Winnebago County Recycling Facility - Call or visit the County website for details.

### **Acceptable Household Hazardous items:**

- \* **Automotive** - fuel additives, transmission, brake and starter fluids.
- \* **Cleaners** - drain, oven and household; turpentine, solvents, varnish/stain, pool chemicals, polishes and aerosol sprays.
- \* **Lawn/Garden** - herbicides, insecticides, fungicides, weed killer, and poisons.
- \* **Misc.** - oil & lead based paint, grease & rust solvents, paint thinners/strippers, adhesives/driveway sealer, wood preservatives, spray paint, mercury.

## ◆ Electronics can be taken to Winnebago County Recycling Facility 920-232-1800

- \* Televisions - less than 32" (**Residential Only - Limit 4**) - \$15.00/each
- \* Televisions - 32" or greater (**Residential Only - Limit 4**) - \$20.00/each
- \* Keyboard, mouse, speakers, cords, cell phones (**Residential Only**) - no charge
- \* Monitor, laptop, CPU, printer, DVD player, VCR (**Residential Only - Limit 4**) - \$5.00/each

## ◆ PAINT

Latex paint - once the paint is dry, put the cover back on and dispose of in the trash

*(paint can be dried by allowing it to air dry or by adding sand, kitty litter or latex paint hardener).*

Oil and Lead based paint - treat as Household Hazardous Waste.

◆ **SHREDDED PAPER COLLECTION**

\* **Shredded paper cannot be placed in your recycling cart.**

- \* Shredded paper can be thrown in your regular garbage bin in a bag.
- \* Shredded paper can be taken to Oshkosh Paper Salvage @ 1860 Harrison St., Oshkosh, WI 54901, (920)-235-2000 for free. There is a row of blue curbside recycling carts that shredded papers can be placed in.

◆ **USED ENGINE OIL DROP-OFF SITE** - Fox Crossing Municipal Complex

- \* Clean used engine oil only.
- \* Drop-off site is open 24/7.
- \* Drop-off site is monitored by security cameras.
- \* You MUST take your empty containers home with you.
- \* *Drop-off site is located on the west side of the Municipal Complex. Look for the large, white holding tank.*

◆ **TREE AND BRUSH CHIPPING** - performed by street laborers

- \* Tree & brush material will be collected on your regular garbage collection day, as indicated on the calendar under "chipping".
- \* Tree & brush material must be placed curbside by 6:00am & no earlier than 48 hours prior to your regular garbage day.
- \* In the event village crews can't complete the collection route on your scheduled day, collection will continue the following day until the routes are completed.
- \* Place branch piles in a single row with all "cut ends" toward the road; piles shall not exceed 5 ft. in height; branches cannot exceed 6 inches in diameter. Keep branches long for the safety of our crew.
- \* If you missed your scheduled collection, you can take the material to the drop-off site at 2000 Municipal Dr.
- \* Violations of the Tree and Brush Chipping Policy will be tagged. Failure to remove such material within 24 hours could result in a citation being issued for violation of Village of Fox Crossing Ordinance 10.03(7).
- \* If you hire a professional service to cut down a tree(s)/brush, they shall remove the materials.
- \* The entire Tree and Brush Chipping Program Policy can be found on the village's website.

◆ **YARD WASTE & LEAF COLLECTION** - performed by Harter's Fox Valley Disposal

- \* Yard waste/leaf collection occurs every other week, on your garbage day, as indicated on the calendar.
- \* Yard waste includes: leaves, bundled twigs and sticks (bundles are not to exceed 4 ft. in length, 2 inches in diameter and must weigh less than 50 pounds), roots or shrubs with intact root balls, clean woody vegetative material no greater than 6 inches in diameter and garden debris (no mulch or grass).
- \* Use biodegradable yard waste paper bags or containers with lifting handles (30 gallon capacity or smaller).
- \* **Yard waste in plastic bags are BANNED from the landfill & will NOT be picked up curbside.**
- \* **Grass clippings and mulch are NOT collected by The Village of Fox Crossing or Harter's ever.**
- \* **Grass clippings/mulch/leaves/yard waste are NOT accepted at the Tree & Brush Drop-Off Center.**
- \* Grass clippings can be taken to the Winnebago County Landfill in Oshkosh or the Outagamie County Landfill in Appleton.

◆ **STREET LIGHTS**

Street lights in the Village of Fox Crossing are maintained by WE ENERGIES. To report a malfunctioning or burnt out street light, contact WE ENERGIES at 1-800-242-9137, press "0" for the operator. The pole # is very helpful when calling WE ENERGIES; located on the pole, at eye level, on a metal strip.
