#### PARK COMMISSION MEETING MINUTES

May 11, 2022

The Commission meeting was held at the Municipal Complex, 2000 Municipal Dr., Neenah, and was called to order by Commissioner Patzwald at 6:00PM. The Pledge of Allegiance was recited and roll call was taken.

# **APPROVAL OF MINUTES AND DISCUSSION OF EXPENDITURES**

The Park Commission dispenses with the reading of, and adopts, the April 13, 2022, regular meeting minutes. Commissioner Beson motioned to accept the minutes, seconded by Commissioner Vandenberg. Commissioners Elliott and Patzwald abstained. Motion carried.

# PUBLIC FORUM

• Rae Tyriver – Resident of O'Hauser Park Neighborhood. Many new residents are dog owners and the dog waste has increased in the last five years. The neighborhood would like the Commission to consider Pet Waste Stations around O'Hauser and the trail system. Rae believes additional bins and bag stations would encourage owners to pick up after their pet(s). An idea would be to have local pet owners sponsor stations (i.e. name plaques), and to distribute flyers indicating the villages dog ordinances as well as the locations of the pet waste stations to residents in the O'Hauser Park area when they purchase dog licenses.

# **DISCUSSION/PRESENTATION**

A. Electric Scooters on Trails – Director Geiser shared that BIRD Scooters has an interest in bringing their scooters to the Village of Fox Crossing. Director Geiser asked for feedback/thoughts from the Commission as it relates to changing the ordinance to allow for this usage. Commissioner Beson feels the trails are used for "muscle powered" activities, and the scooters don't appear recreational. Commission Otto had the same objections as Commissioner Beson with the trails only being used for riding bikes and pedestrian use. Commissioner Elliott has seen them in Appleton and would like to try it. Commissioner Vandenberg likes this idea better than driving a car, and thinks the Commission should allow it for one year, then re-assess. Commissioner Patzwald would like to try it on the loop. Commissioner Wollerman walks on the Trestle Trail and feels it might be difficult for the scooters to always stay on the right side. If this is passed, the profits/revenue should be used to put up signs indicating 'walkers to the right, bikers on the left.' The consensus of the Commission was to try for one year limit usage of the scooters to the loop. Village Manager Sturgell sat in on the discussion and indicated that he and Director Geiser would take the proposal to the Village Board.
