Fire Chief Brian Harbison announced the Fire Department recently received their 5<sup>th</sup> reaccreditation which is a quite a significant accomplishment. This year's requirements were much more extensive due to the department having to meet the 9<sup>th</sup> edition requirements, which was a complete change from the prior reaccreditation processes. He stated the Village is also the longest tenured Fire Department to maintain this level of accreditation.
