RES #230213-1 <u>APPROVE STATE/MUNICIPAL AGREEMENT FOR A STATE-LET URBANIZED</u> <u>AREA STP-URBAN PROGRAM PROJECT – EAST SHADY LANE</u> <u>RECONSTRUCTION FROM COUNTY HIGHWAY CB TO COLD SPRING ROAD</u>

WHEREAS, in 2022, the Village of Fox Crossing applied for, and received, a Wisconsin Department of Transportation (WISDOT) Surface Transportation Program (STP) Urban grant for the asphaltic reconstruction and urbanization of East Shady Lane from County Highway CB (CTH CB) to Cold Spring Road; and

WHEREAS, in order to receive the grant, the Village must enter into a State/Municipal Agreement (SMA) with WISDOT to memorialize the terms of the grant program; and

WHEREAS, the awarded STP-Urban grant would provide funds for 80% of the reconstruction and urbanization of East Shady Lane from CTH CB to Cold Spring Road, to include a 10 foot trail on one side of the road, to a maximum grant amount of \$1,776,802; and

WHEREAS, the Village of Fox Crossing agrees to fund the remaining 20% of the costs (estimated at \$941,448), and any costs over \$1,776,802; and

WHEREAS, the project will be a State-let and managed project, to be constructed in fiscal year (FY) 2026.

NOW, THEREFORE BE IT RESOLVED, that the Village of Fox Crossing Board of Trustees hereby approves the State/Municipal Agreement for a State-Let Highway Urbanized Area STP-Urban Program for the East Shady Lane Reconstruction project, as attached.

RES #230213-2 <u>RESOLUTION DECLARING OFFICIAL INTENT TO REIMBURSE EXPENDITURES</u> <u>FROM PROCEEDS OF BORROWING</u>

WHEREAS, the Village of Fox Crossing, Winnebago County, Wisconsin (the "Municipality") plans to undertake Road Reconstructions and Resurfacings, Stormwater Improvements, Parking Lot improvements, Pedestrian Trail Paving, and the Replacement of the Street and Park Department Radios, (the "Project"); and

WHEREAS, the Municipality expects to finance the Project on a long-term basis by issuing taxexempt general obligation bonds, revenue bonds or general obligation promissory notes (the "Bonds"); and

WHEREAS, because the Bonds will not be issued prior to commencement of the Project, the Municipality must provide interim financing to cover costs of the Project incurred prior to receipt of the proceeds of the Bonds; and

WHEREAS, it is necessary, desirable, and in the best interests of the Municipality to advance monies from its funds on hand on an interim basis to pay the costs of the Project until the Bonds are issued.

NOW, THEREFORE, BE IT RESOLVED by the Village Board of the Municipality, that:

<u>Section 1. Expenditure of Funds</u>. The Municipality shall make expenditures as needed from its funds on hand to pay the costs of the Project until Bond proceeds become available.

<u>Section 2. Declaration of Official Intent</u>. The Municipality hereby officially declares its intent under Treas. Regs. Section 1.150-2 to reimburse said expenditures with proceeds of the Bonds, the principal amount of which is not expected to exceed \$4,928,000.

<u>Section 3. Unavailability of Long-Term Funds</u>. No funds for payment of the Project from sources other than the Bonds are, or are reasonably expected to be, reserved, allocated on a long term basis, or otherwise set aside by the Municipality pursuant to its budget or financial policies.

<u>Section 4. Public Availability of Official Intent Resolution</u>. This Resolution shall be made available for public inspection at the Village Clerk's office within 30 days after its approval, in compliance with applicable State law governing the availability of records of official acts including Subchapter II of Chapter 19, and shall remain available for public inspection until the Bonds are issued.

Section 5. Effective Date. This Resolution shall be effective upon its adoption and approval.
