CALL TO ORDER

Chairman Koeppe called the meeting to order at 5:17pm

APPROVAL OF MINUTES

1. Community Gardens

Mr. Scheibe said that there were some issues with the hoses where when you closed the level, water would just spray out sporadically. Some of the hoses have towels and zip ties because it does it so much.

Ms. Yang said that she and Isabel talked to Eddie, the Park Foreman, about that and he said that gardeners are supposed to just close the lever slowly and make sure that the nozzle is open.

Mr. Scheibe said that it still sprays a ton of water.

Chairman Koeppe said that he will check with the Utility Superintendent, David Tracey, to see if it's the valves.

2. Plastic Film Recycling

Chairman Koeppe said that two more benches will be coming. They are backed up due to COVID so it will take about 10-14 weeks.

Ms. Collins asked where they send the benches.

Chairman Koeppe answered that they send them directly to the park and the Parks puts a plaque on it saying where the bench came from.

3. Electronic Recycling

Chairman Koeppe said that the next Electronic Recycling is on October 9th. He asked if the flyer has been put in the Utility Bills yet.

Ms. Yang said that she will follow up with Linda, the Billing Specialist.

Chairman Koeppe said he will announce it at the next three board meetings.

Ms. Romzek said that Greenville cancelled their event again.

Chairman Koeppe said that they would not cancel unless the Municipal Building closes down.

4. Recycling Education Plans

Chairman Koeppe said that last year the Village paid \$7,600 for garbage and recycling fees. He would like the committee to put something in the utility bill but the issue is that departments compete with each other because you can only put one in per quarter. If we mail it out to all the residents, the Sustainability Committee may have to pick up the cost. He will talk to Tracy to get contact so the Village can better educate on the costs of recycling.

2021 GARDENING TERMS

Season Dates

- 1) **January 1** Renewal deadline for current gardeners. We need to know of your intentions by this date.
- 2) **March 1** Plot must be paid in full (new gardeners and renewals) or it will be given to a gardener on the waiting list.
- 3) **May 1** Plot preparation should have begun by this date. Weeding and tilling are your responsibility. Check the Community Garden Facebook page for fee-based tilling service options: https://www.facebook.com/Village-of-Fox-Crossing-Community-Gardeners-657458944431453/.
- 4) **June 1** Gardens not being maintained will be cleared and reassigned. A two week notice will be sent prior.
- 5) **November 1** Gardeners must clear annual vegetation, weeds, vegetable stalks (excepting winter crops), and all tools, pots, stakes, compost bins, etc.*

<u>Fees</u>

- 6) Garden rental fees are non-refundable. *Please only sign up for a garden if you are fully committed.* When you are assigned a plot, that plot immediately becomes your responsibility. If there are extenuating circumstances, contact the Village to discuss.
- 7) The cost is **\$25** per year for Village **residents** and **\$30** per year for **non-residents**. The fee covers administration and maintenance costs and the cost of water and signage.
- 8) Please see "end of season" section for additional information.*

Garden Plot Registration

- 9) Plots are assigned on a first come/first serve basis and filled in the order in which the registration forms arrive by mail or in person. A waiting list will be maintained for applicants for whom no plot was available.
- 10) There is a limit of one garden per household. The granting of a second garden may occur *only* if there are still plots available after all applicants on the waiting list have received a plot. *Note: Gardeners who have previously violated any of the terms of this agreement will not be eligible for a second garden plot.*
- 11) Garden plots are assigned to one person only and are not transferable. Others may garden at your site, but the responsibility for payment of fees, cleanup and other duties at the site will be the responsibility of the individual whose name is assigned to the plot.
- 12) New gardeners will receive a plot number once they have been assigned. Please do not do any work until you have received your assigned number.
- 13) If you are unable to maintain your garden site, contact the Village as soon as possible so that your site can be reassigned.

Fertilizing and Weed Control

- 14) Gardeners are encouraged to garden organically by using organic materials such as compost and manure to fertilize their gardens. Leaves, straw and grass clippings are good mulch around plants. Mulch also helps control weeds and maintains moisture so you have to water less.
- 15) If any compost/manure are brought to the gardens, no trucks are allowed to be driven onto any unpaved areas and no left overs shall be stored at the park.
- 16) We encourage you to be selective of the herbicides and pesticides you use. Read labels carefully and apply wisely.
- 17) Weed your garden on a regular basis. Weeds may not become taller than 8 inches. Gardeners agree to keep the garden & garden edges free of weeds, diseased plants, insect-infested plants and over-ripe vegetables. Weeds are the leading cause of plot forfeiture.

Adjacent Paths and Borders

- 18) Wood chips may be used in individual plots. Straw is also great mulch and may be used in plots.
- 19) Renters *must* keep plants and debris inside their own plots. Any plant that protrudes into the next plot or an adjacent walkway may be trimmed by the lawn mowing staff.

Watering

- 20) Water use at the garden is *only* limited to watering plants. The water is not safe to drink.
- 21) Water your garden by hand only. No sprinklers or soaking hoses are permitted! Gardeners need to be diligent in shutting the water off after use (gardens can be flooded due to water not being shut off!).
- 22) Spigots and hoses will be provided by the Sustainability Committee and hoses must be coiled on the hose stands out of the path of grass mowers after use.

Children

23) Parents are encouraged to bring children to the garden and introduce them to the wonders of gardening. Please monitor their behavior and whereabouts at all times.

Pets

24) Dogs and other family pets are not allowed in Village parks, including the gardens.

Garden Site

- 25) Garden plots are numbered. These numbers must remain with the garden plots for the duration of the season. **Please do not remove the plot numbers**. All gardeners must respect their own garden space and the gardens of others by keeping their sites tended and within their own boundaries.
- 26) Watering cans, tools, chairs and benches are not to be left at your garden plot. If any of these items are left in your garden, notice will be placed that they have been removed and may be returned for a \$5.00 charge.
- 27) It is strongly recommended that gardeners maintain a compost pile at the center of their garden throughout the gardening season to compost weeds and other organic materials. Compost makes excellent mulch.
- 28) Taking produce from other garden plots will result in a loss of gardening privileges for future growing seasons.
- 29) Vehicles must be parked in designated parking areas only, not on walkways.
- 30) If, at any time throughout the season, you are caught dumping weeds or plant debris anywhere on park property, you will lose your plot.
- 31) The use of banned substances, harassment, theft or criminal behavior will be grounds for expulsion. Report any unusual or unwanted activity to the Fox Crossing Police Department at 920-720-7109. For emergencies, please dial 911.
- 32) **If you see poachers** please contact the Village of Fox Crossing Police Dept. non-emergency number at 920-720-7109.
- 33) **If there are water issues** (such as leaks or malfunctioning spigots) please contact Farrah Yang (920) 720 7105. If leaving a message reference the spigot number and clearly explain the issue.

*End of Season


- 34) At the end of the season, all weeds and vegetation should be cut and taken home.
- 35) Plots shall be clear by November 1st, weather permitting.
- 36) Gardeners who do not clean up their plots will lose gardening privileges and be billed \$50.00/hour, not to exceed \$150, for plot clean-up.


